AGENDA

1. To elect a Chairman of the Committee

- 3. Receive Acceptance of Sub-Committee Membership from co-opted MIGGS members.
- 4. To receive Register of Members Interests from co-opted MIGGS members.
- 5. Declarations of Interests (LA 2011 s31)

Members to declare any interests, including Disclosable Pecuniary Interest they may have in agenda items that accord with the requirements of the Parish Council's Code of Conduct and to consider any prior requests from members for dispensations that accord the Localism Act 2011 s33(b-e). (NB this does not preclude any later declarations)

- 6. To review the results of the MIGGS conducted survey into public opinion of the need for a pedestrian safety initiative on Station Road, agree actions.
- 7. Referring to the Terms of Reference, to consider and agree actions of the sub-committee regarding the following points:
 - 7.1. Where required to define the brief for and commission on behalf of the Council a professional, expert report from a suitably qualified highways consultant
 - 7.2. To advise the council on the choice of consultant and the most appropriate procurement process
 - 7.3. To obtain advice and information on behalf of the Council from the highway authority
 - 7.4. To obtain and evaluate evidence of the views of residents at large and of special interest groups, including but not limited to groups representing the immediate residents to any project, the elderly and disabled people and parents and carers of young children
- 8. Matters for future discussion.
- 9. To confirm the time and date of the next meeting

It may be agreed to decide the date of the next meeting as needed by e-mail between the sub-committee members, in conjunction with the Clerk.
