

Notice of a Council Meeting of the Goring-on-Thames Parish Council

Monday 10th January 2022 at 11:00am, Gardiner Recreation Ground, Near the Pavilion

All Councillors are summoned to a Meeting of Goring on Thames Parish Council.

Members of the public and press are invited to attend all council meetings. (Public Bodies (Admission to Meetings) Act 1960)

Prior to the start of the meeting; Questions and comments from members of the public (limited to 10 minutes in total)

NOTE: Subject to all councillors being present, this period may start as early as 10:50.

This provides an opportunity for members of the public (who are not usually permitted to speak during the meeting except by special invitation of the Chairman) to participate before the start of the meeting. Members of the public may make only one address to the council of no more than three minutes' duration and only concerning topics on the agenda. No decision can be taken during this session, but the Chairman may decide to refer any matters raised for further consideration.

NOTE: At the meeting of 20th December 2021, in light of the ongoing COVID pandemic and current "work from home if you can" guidance, the Council delegated powers to the Clerk, under LGA 1972 s101. This meeting is primarily to set the Precept and budget for the year ahead, which cannot be delegated to the Clerk and consider some urgent matters.
