21.20.5. To apply (as delegated by the Full Council) to OCC Highways for a Priority Pedestrian Lane trial on Station Road that would include suspension of parking bays, including determining key success measures to be able to evaluate after the trial period has ended and agree other actions.

To ask not just Station Road; but all users; including do they feel safer and were there any issues with the trial. To discuss and meet with OCCH to ask them how to make people more aware of what is happening.

Resolved: Approved unanimously [ACTION DB] Ask OCCH to meet and discuss the potential repairs; signage and how to measure the success.

21.20.5.1. To agree signs to be displayed during the trial period, highlighting alternative parking areas.

See item 21.20.5 and ask for help with the signage as well.

21.20.6. To consider the additional information from OCC Highways regarding planting outside Rectory Garden, to prevent parking on the verge.

Resolved: Approved unanimously [ACTION DB] Ask OCCH to meet and discuss way forward.

21.20.7. To receive a verbal report on the Yew Tree Court Junction.

A member of the committee had met with the Yew Tree Court resident, and discussed the issues. The member of public asked for a sign to be placed on the Parish Council owned wall. It was highlighted that OCC had already stated the road markings and signage was sufficient for purpose.

Resolved: Approved unanimously [ACTION DB] Ask OCCH to meet and discuss way forward.
