Note: I did not forward the request to our Cleaner who was in post at the time. He does not have a council email address, nor was he included in any of the conversations had within the council regarding this matter.

Thank you for taking the time to report a potential breach of the Coronavirus legislation.

We have created a reference number which you may wish to keep and if you need to report further breaches at the same location or by the same individuals we would be grateful if you quoted this reference when you contact us, it is URN 340 29/5/2020

A Police Unit will be dispatched as soon as available to give guidance regarding compliance with current regulations. You may also wish to contact your Local Authority / Quality Care Commission, to make them aware of your concerns.

We are receiving hundreds of reports every day relating to potential breaches of the legislation and dealing with them alongside normal policing which includes responding to other emergency and non-emergency calls.

In order to do this effectively we will prioritise reports of groups gathering which are happening at the time because they pose the greatest risk of spreading the infection. If you see this happening we would encourage you to call 101 to help us respond as quickly as possible.

With some other reports you may not see us respond but please bear in mind that does not mean we are not doing so, nor does it mean we are doing nothing about it.

Any and all reports we receive are investigated and will be reviewed on your local policing area where, even for those we could not get to quickly, we are using the information you provide to identify where there are patterns in the times and locations you provide.

You telling us when and where people are regularly not complying is really important and useful.

This information is used by your local policing teams so that they can better target their patrols and be in the right places at the right time to discourage gatherings, keeping people safe and protecting the NHS.

We went there at the weekend, and again on Wednesday lunch time.

It was extremely well organised and very safe, with one 'family' group at a time ordering and in the shop at any time, and a strict one way system to avoid people passing one another. This photo is misleading due to the angle and distance it has been taken from. The Swan has the massive advantage of extensive grounds. They have laid out benches with big distances between. We saw <u>no</u> flouting of the C19 arrangements. Furthermore the police arrived when we were there at the weekend because someone had apparently already complained, but they found nothing untoward and left shortly afterwards.

It's unfortunate that Catherine Wheel, Miller and Barleycorn do not have sufficient space, otherwise I'm sure they would want to do the same. But hopefully the rules will change soon so they can resume business and making a living too.

Dear [Clerk]

I understand that you have been exhorting members of the Goring Parish Council and others to complain to the police about our takeaway service at Coppa Club.

First let me assure you that, prior to reopening, we had a full and thorough review of all operational protocols by our health and safety consultants, Surefoot, and have also taken full legal advice as to how we should operate within the ever changing CoronaVirus legislation. All social distancing and infection control measures are rigorously enforced throughout the ordering, waiting and food delivery process, with regular cleaning of all surfaces and other sanitisation measures, and a one way system to ensure no inadvertent mingling or infection risk.

Regarding use of the Swan's gardens as one location where customers may choose to eat their takeaway (and many just go straight home or elsewhere), please be clear that this is just one choice of the many open spaces available round about the area. However, in consultation with our advisers, we felt that it was better for the Streatley and Goring community to specifically ask the Swan (which is a separate legal entity from Coppa Club) to offer a green space, where there would be bins available for rubbish that would be emptied regularly, where all litter could be removed regularly, where all surfaces would be cleaned regularly, and where we would have staff available if need be to at least suggest (we cannot enforce) to those picnicking to adhere to social distancing. If you have been to the gardens, you will have seen that this provision of bins and litter collection has also provided a valuable service to many non-Coppa customers to come and picnic there.

Bear in mind that one of the objects of licensed premises is that eating and drinking can be controlled in a civilised way. The alternative being that we continue to provide a takeaway service, close the <a href="Swan gardens">Swan gardens</a> to the public, and people gather as they choose all along the river bank, eating drinking and leaving litter all over our beautiful countryside. Surely this would be far worse?

We have now had four visits from the police, which seems an immense waste of their time, when they have so many more important things to do. We have also had two visits from Trading Standards Officers. To comply with the very strictest interpretation of the CoronaVirus legislation, we have removed available tables and seating from the Swan gardens, which means people have to sit on the grass or bring their own chairs. I am quite certain that this achieves nothing from a safety point of view, as it actually means people tend to picnic closer to each other than when the tables were there, which were obviously set out a good distance apart. So probably it has made the experience slightly less safe and less enjoyable for the public, without achieving any advantage, but, nonetheless, we are quite happy to comply with the strictest letter of the law.

You will of course also be aware that Government scientists (supported by numerous transmission studies) have repeatedly said that the virus does not get easily (if at all) transmitted outside. Transmission is almost exclusively in indoor spaces where people spend more than 15 minutes in very close proximity. By contrast, UV light typically renders the virus inactive inside 90 seconds and, in the open air, infection is nearly impossible. This is why the regulations around visiting outdoor spaces have been relaxed so much recently and why all councils (and other public and private owners) have been encouraged to open their gardens and green spaces.

I, or one of my senior team, would be absolutely delighted to meet you, or any members of your Council, at Coppa Club to go through our entire operating process in order to try to put your mind at rest and to answer any concerns that you may still have. And please may I ask you, and all your members, to take up this invitation before calling out the police another time. The local police are doing a great job around our area in a difficult time and it is not fair on them to needlessly create tension with the many local residents who are our customers at Coppa Club.

Obviously we all now hope that, as the circulation of the virus recedes, life will return to normal as quickly as possible and we will be able to provide an excellent facility and service to members of the Goring and Streatley communities, as well as employment to many local people.

Thank you for reaching out to the Parish Council. Please can I first take a moment to explain my role. As the Parish Clerk, I am the proper officer of the council and therefore my role is to advise the council (and by extension its members) on proper procedure, laws, legislation and obligations, such that they can make appropriate decisions. I also receive correspondence from members of the public and advise them of the appropriate actions to take if the issue is not a Parish Council responsibility.

Your statement of "I understand that you have been exhorting members of the Goring Parish Council and others to complain to the police about our takeaway service at Coppa Club." is wholly untrue. To each and every complaint to the Parish Council about the copious visitors to Goring, the current Traffic Issues, social distancing issues in and around Goring and Streatley, issues with street lighting, pot holes, rubbish etc has been either (depending on the incident):

- This is a 101 issue, if the incident is in progress ring them, if you are reporting something which is no longer in progress use the online form.
- This is a FixMyStreet Issue, they have an online form, or a smart phone app which then picks up your location and you can include a picture of the relevant item
- Or the parish council has made/ taken the appropriate action.

Regarding the visitors using the gardens at the Swan to eat their takeaways, I received copious reports and asking what could be done, each time advising the same until I sent the e-mail to which you are referring.

The law is very clear that takeaway must be consumed off premises, and therefore I strongly urge all members of the community be they parish councillors or members of the public, to report all infringements to the police using the 101 system.

This would be relevant to any and all facilities across England at this time. This information is available on the gov.uk website and is being used as a reference by Parish Councils across England.

In respect to the other issues which are being raised to me almost daily and for full transparency, I have also submitted a report to OCC to log the issue of the narrow bridge over the river, and the inability for pedestrians to socially distance, with a request for some traffic calming of some sort to increase the safety of our many visitors to the villages of Goring and Streatley.

In addition the Goring and Streatley Communications Group of which I am a member, is also looking at updating the visitors boards, with a new map showing pinch points and places throughout Goring and Streatley where it is impossible to maintain 2m social distancing if you happen upon walkers coming from the opposite direction. The "Visit Goring and Streatley" website is also being updated to include some of this vital information including revised opening times of some of the local facilities.

While it is not our intention to create any additional difficulties for local businesses we do have legal responsibilities and our actions were taken to ensure both visitors and residents alike are kept safe and the appropriate laws and government requirements are being adhered to.

Dear [Clerk]

Thank you for your prompt response on a sunny Saturday. Please let me start by repeating my offer to you or any member of the council to come to see the operation in progress. I can assure you we are doing everything possible to try to do it right.

I would also like to clarify a few points:

- We are not, and never have intended for people to be eating or drinking on the Coppa Club premises (which is the whole of the terrace before you reach the footbridge into the gardens). For the first few days, some people were opening their drinks and drinking them while waiting for their food order; after discussion with the TSO, we have removed all seating from this area and signed it very clearly that this is not permitted
- Regarding the gardens beyond (owned by the Swan which has common but not the same shareholders), when the Government guidance changed to encourage public and private bodies to open gardens and green spaces, the decision was made to open all the grounds (and car park) to the general public. This has been very popular with local residents for walks by the river, picnics, etc. Closing any of these grounds specifically to people who have bought takeaways from Coppa, while remaining open to picnickers and others is impossible, and would anyway seem perverse and absolutely not what is intended by Government.
  - As a secondary observation, operating the takeaway without the car park would be mayhem and, if the car park is open, it is near impossible not to open the grounds
- In discussion with the Trading Standards Officer, in any event, the detail of the legislation requires specifically that we should not provide seating that customers could use on the premises, even outside. While technically the benches that were in the gardens were there anyway and were not Coppa Club's, we have nonetheless removed them at the request of the Officer. If anything this is less encouraging for social distancing, but we have done it to comply with the letter of the law

To be honest, and we have been round the premises twice with the TSO and four times with the police, I believe that this is now the best achievable outcome, which complies with the details of the legislation but still provides a safe and good customer experience. Shutting the gardens completely (which does not appear to be required by the legislation and is directly in opposition to Government guidance) would engender worse compliance with social distancing and have the inevitable consequence of more litter all along the river path and probably the Streatley recreational area, where there are tables but few bins and no regular emptying of them.

I would also reiterate to you the latest Government guidance and scientific advice, which is that the virus is not well transmitted outside, if at all. I think therefore you can be assured that there is no benefit from some of the other outdoors measures in the village that you were discussing. Ministers are briefing that the (near)

normal operation of pub gardens and other outdoor hospitality spaces is to resume shortly, so hopefully the whole debate about the detailed technical interpretation of hastily drafted and often conflicting legislation will no longer be necessary.

I remain available to meet with or speak to you or members of your council.

Dear Councillors and Assistant Clerks,

I have today received a Freedom of Information Request from a member of the public.

Before I proceed my I first take a moment to remind you all of the following facts:
