GPC Previous Response: OBJECTS overbearing & unneighbourly.

Previous applications for this property were refused by SODC Planning and on appeal, and the mitigations applied to this application still do not address all of the reasons for the last refusal. Goring-on-Thames Parish Council agrees with and would like to highlight the issues raised by 21 Milldown Avenue on this application, and would like to draw your attention to their comments regarding: the proposed development being overbearing & unneighbourly. The revised proposal does not adequately deal with the concerns regarding the party wall and rainwater runoff of the proposed development over the neighbours' property. Should this application be approved, we attach the general planning informative.


Application to OCCH for SIDs throughout the village of Goring



23.15.6. To approve any response to the GWR consultation on closure of the ticket office at Goring and Streatley Station

Resolved: Unanimously approved to submit the response: The proposal fails to recognise the real scale of customers and the diversity of their needs making demands on Goring and Streatley station, where staffed ticket offices are vital. It does not factor in the wide range of tourists which use our beautiful villages. The villages of Goring and Streatley have double the national average rate of 60y+ residents and an age profile very different to many other areas. The current ticket machine is badly sited, too high for wheelchair users, covered in glare at peak travel time and often broken or out of tickets. Our residents require a smooth-running station as a mainline to London stations. Also we seek to avoid residents becoming unemployed by staffing redundancies at the station.

23.15.7. To consider a proposal for Sheffield Cycle Stands throughout the village (approx. £35 per stand)

Eight locations were originally proposed for Sheffield Cycle Stands, after discussion in the meeting this reduced to 6.

Example of a stand:



1. [GPC] Gardiner Pavilion - unused hard standing outside water tank garage door.



- 2. [OCC] High Street on the traffic calming build out, outside the arcade.
- 3. [OCC] Highstreet opposite Pierreponts, change part of the barrier to be similar to the bench.
- 4. [GVH] Goring Village Hall remove weeds to the right of the building, at the front.
- 5. [OCC] Corner of High Street & Manor Road on paved section outside the entrance to the Rectory Garden.
- 6. [SODC] Wheel Orchard Car Park repurpose a narrow parking space, potentially twinned with adjacent EV Parking Spaces going forward.

[ACTION] RW to contact St Thomas' Church to find out if they would be interested installing some at the same time.

[ACTION] LW to write to SODC and VH re: SODC locations, and potential for EV points adjacent to the lampposts.

The village is sorely lacking in highly visible and secure locations to which bikes can be chained. Subsequent to 6 locations being chosen in the last meeting of the TMPPS Committee, a representative of Oxfordshire County Council Highways Department has met with a Committee Member to discuss the proposals. The Following was discussed:

OCCH has a supply of Sheffield stands, remaining from previous active travel initiatives, these are to be donated and fitted free of charge.

Just one location requires Parish Council approval, Gardiner Pavilion – 2-off stands on the unused hard standing outside water tank garage door.

[Proposal to Full Council] To approve installation of Sheffield Bike stands on the unused hard standing outside the water tank garage door at the Gardiner Pavilion – installation not to foul the doors, and send thanks to OCCH for their agreement to install these at their expense.

The following further locations were agreed, however no GPC approval is required for these, the TMPPS Committee with the Village Hall Committee to facilitate the installation in this location.

- 1. [OCC] High Street 1-off stand on the traffic calming build out, outside the arcade.
- 2. [GVH] Goring Village Hall 1-off stand on to the right of the building, at the front.
- 3. [OCC] Corner of High Street & Manor Road 2-off stand on the wide paved section outside the entrance to the Rectory Garden.

Whilst no formal assessment of the effect of the traffic calming on the High Street has been conducted. Observations of cars travelling up the High Street between the junctions with Cleeve Road and Wallingford Road appear to show cars speeding up considerably on this long straight section of road.

[Proposal to Full Council] To approve pursuing the installation of 1-off full carriageway width speed hump, similar to that outside the shop frontages, budget £9,000 for design and public consultation using Glanville Group / OCCH.

Further back ground. OCCH have confirmed they cannot progress a scheme such as this in FY 2023-2024 due to their current commitments to our parish

- Yellow Line Review
- Sheffield Bike Stands
- Station Road Pedestrian Priority Lane
- Speed Signs.

They have confirmed that should the parish prepare the scheme ready to consult in FY 2024-2025 they may then be able to provide the OCCH officer resource to progress the scheme further. Likely the PC will need to pay for the installation – currently unknown cost.

Proposal is to install a speed bump similar to the one previously installed on the High Street in 2021.
