3 Public Forum

The Chairman confirmed that the Landscape and Visual Impact Report would be available shortly.

4 Minutes of the previous meeting

It was agreed that all matters arising are covered by today's Agenda

6 Chairman's Report

The Chairman used the previous NP report to GPC (on GPC Website) to update the meeting on progress and issues. Specifically, the issue of the school was mentioned and it was confirmed that the current SODC target for Goring is an additional 86 houses and that the overwhelming feedback from the village (the strongest feedback on any topic) is that the people in Goring do not want additional housing beyond that level. This in its own right does not justify the building of a new school. It was confirmed that the provision of a new school is not in the NP remit and is not being considered by the NP.

7 Finance

The position was summarised. Two grants had been approved totalling £18,000 against a £23K Budget. It was confirmed that expenditure against this budget was extremely tight.
