Plan 16/113 **Election of new Chairman/Deputy Chairman**

The vote had been taken at the full council meeting the previous evening but was re-visited Cllr Hall proposed Cllr Brooker to be re-elected Chairman (this was unanimously approved) and Cllr Brown to be re-elected as Vice Chairman (this was unanimously approved).

Plan 16/116 **To approve the minutes of the meeting of 24<sup>th</sup> April 2016.**

Plan 16/118.1 **P16/S1150/FUL Bromsgrove, Croft Road, Goring on Thames, RG8 9ES.**  
New House with linked garage block (with ancillary roof accommodation).

Cllr Hall said the previous design for the house (which the Committee had approved) had been far more modest, this design was larger and had a bigger roof. The large windows at first floor level, on a constrained site surrounded by other houses, is unneighbourly. There would be overlooking and privacy problems. Cllr Reavill noted that Highways had not yet objected. It was noted the design was sold as “sustainable” as it encompassed a home office. After further discussion Cllrs agreed the proposal was too bulky, too large was not domestic in scale and there could be overlooking problems and be unneighbourly.

Cllrs then voted unanimously to recommend the application for **REFUSAL**.

Cllr Reavill raised whether or not the Chilterns Conservation Board and National Trust should be informed about the Council's legal action over the

weir. Cllr Brooker said they had been approached at the time of the first application and the Chiltern Conservation Board was in fact slightly in favour “as community based renewable energy schemes are something they wished to support, as long as they do not conflict with AONB objectives”. Cllr Reavill said he thought they may wish to remain neutral but there had been a report from the National Trust about problems with planning and the AONB, in particular to do with CAB at Wallingford, and that the view was the requirements of the AONB were being poorly considered. Cllr Hall said she thought the Chiltern Conservation Board / Chiltern Society were just another consultative body so had limited powers. Cllr Wills said there were two different bodies, the Chilterns Conservation Board and the Chilterns Society. Cllr Hall mentioned that the appeal conducted by a public hearing last year for a housing development at Woodcote the matter of Chiltern Conservation Board’s role and consultation with them had been raised. Specifically questions were raised by the defendant because they been consulted but had chosen not to respond. Cllr Hall’s understanding of the answer given by specialist planning barrister was that Chiltern Conservation Board were simply another consultee body so their input could not be insisted upon and would not necessarily make any difference to the decision. Cllrs discussed further the pros and cons of whether these bodies should become involved in the weir action.
