GENERAL OCC REPORT

ROAD RESURFACING

I've had a number of complaint's about the quality of the work of the recent spate of road and path resurfacing.

Don't be fooled it's not really resurfacing it is a slurry seal to help preserve the underlying structure

What they've done is basically to apply a slurry coat to the existing surface, while it provides a new wearing surface and bonds any loose material together it's not designed to do anything about uneven surfaces as it follows the existing surface.

It is a relatively cheap and quick solution (compared to a proper resurface) which the liberal administration has gone for as against a more expensive but longer lasting resurface.

It's made from emulsified asphalt and generally depending on use lasts 6-8 yrs.

Not very attractive in my personal view and given that a proper maintained resurfaced pavement could last at least 25 yrs its value for money is questionable.

It's been put to me this is so the administration can say there looking after the roads and get them through next years election. Not being party to the inner workings of the liberal administration I couldn't comment, I'm just disappointed a better job wasn't done.

COUNCIL MOTIONS MEETING 9th July

One motion I'd highlight from the meeting due to it's importance for school age parents particularly in rural areas is:-

This Council has not historically run its Spare Seats scheme for school bus places in an optimal way. Parents and carers have too often been left in an unenviable position further to changes, with elected members often left in the dark about changes affecting schools in their divisions.

According to the Oxford Mail (22 May 2024), there is a record low number of buses and coaches being used on Oxfordshire's roads.

Parental choice remains an important principle of the current education settlement and will remain so unless changed by an incoming government. Whilst such a principle remains, it is important that this Council does all it can to facilitate transport to preferred schools at a reasonable cost or on a revenue-neutral basis.

The Council's Spare Seats scheme has aimed to do just this. However, there appears to be increasing uncertainty as to whether it will continue in the same form. Indeed, letters to parents from this Council cancelling services have been sent as recently as 11 June 2024.

The Council requests a briefing for elected members-on the current Spare Seats settlement and requests that the Leader and relevant Cabinet Member(s) bring a report to Cabinet (such report being subject to pre-scrutiny) to address how existing numbers of school bus places can be

maintained and, where possible, increased. In the meantime, this Council requests Cabinet to work with parents, schools and bus companies to ensure continuing provision of affordable school bus places.

This motion passed, which is a good thing, however you have to ask why it took a motion to get the liberal administration to come clean and communicate on this important issue. I've had a number of parents contact me worried about the administration policy on school transport and the concerning rumours swirling around the issue. I say communicate, as of this report I'm still awaiting an update.
